

We were advised that an important meeting of FAA ARAC's Cabin Safety Harmonization Working Group intended to be held in Seattle September 26-27th had been cancelled.

It came as no surprise to us however, that *NADA* set an example to the rest of America by holding your conference, and setting such a brave example by continuing the work of promoting the highest standards of aviation safety and security. Leadership, from yourselves, and your colleagues, working to make *NADA* a voice for all of us can only have achieved this. Your courage has been matched by all delegates attending and by the impressive list of presenters.

Those who have not had to shed tears through loss cannot understand the suffering we are exposed to - and nor should we expect them to. However, the events of September 11th have brought an understanding of grief closer to everyone throughout the civilised world, not just in America. Loss of life may now be felt by those we have challenged and a realisation that change is essential may now be possible.

Some 12 years ago, we trod the path up to the mountain ridge in Japan, and said that it would not be possible to achieve real change through the efforts of SCI SAFE in the UK, or IREI Air Safety in Japan without the involvement of an equivalent organisation in the U.S. Several disasters then occurred in the U.S., which led to the subsequent formation of *NADA*.

In a very short period of time, you have achieved a status and reckoning unmatched anywhere in the world or, for that case, in history. You have not disappointed us and nor will you, but please never forget that your commitment, drive, courage and achievement carries the tears of all those bereaved families throughout the whole world.

You will have our love and support forever.

Dear Friends,

Colleen and I are unable to get down to Washington DC to the annual meeting. Following the horrific event of the World Trade Center (WTC) attack, I have been actively involved in coordination of Emergency Response efforts, in additional to having Colleen's uncle and three friends still missing. We are still in a high threat level of security, still in a State of Emergency, mandatory extra tours, 12-hour days, cancellation of all days off, and quite frankly I am simply needed here.

I was at my desk in Jersey, across the river and in the shadows of the WTC, when I saw both planes hit the towers on September 11th. We sent units to NYC to assist FDNY and lost one of my men in the first collapse. We find ourselves going to more funerals each week than we ever imagined possible, sometimes 2 or 3 a day. Our unit is still rotating tours with FDNY, and working at the ground zero site.

As I sit here in the WTC Emergency Operations Center, I cannot help but to dwell on the magnitude of the death and destruction that did not have to be. I cannot express the frustration I am faced with, knowing that the industry and government "dropped the ball."

Please express my support and convey the message that our mission, to promote safety and security, is needed now more than ever. The public is outraged and demanding change. I am outraged and demanding change. The momentum is there, and we need to get out there publicly so our collective efforts are focused in a productive way.



Captain Ed Gannaway was honored as the first recipient of the <u>ASA 529 TRIUMPH Award</u>, an ordinary person who performed an extraordinary feat towards aviation safety.

"We are here today with a prestigious award to honor the memory of an outstanding individual who, in the face of death, was fearless in his endeavors to perform an extraordinary feat toward aviation safety.

Six years ago, Capt. Ed Gannaway was the pilot of a commuter plane that left Atlanta with 29 passengers aboard. The propeller on the left engine had broken off and from that moment until the plane went down in a hayfield near Carrolton GA, those 29 passengers had 9 minutes and 20 seconds to prepare for the impact that would either end their lives or change them forever. Due to the veteran pilot's experience in aviation, 19 of the passengers survived and live to tell their stories.

Therefore, it is with great honor to announce the first TRIUMPH Award in memory of Captain Ed Gannaway, and in memory of Atlantic Southeast Airlines Flight 529 that went down on August 21, 1995 in Carrollton GA."

SAFETY... NADA/F REQUESTS EMERGENCY ORDER for Required Child Restraint Seats for children under 2

As a consequence of Sept. 11th pilots are now permitted to take immediate response to possible in-flight dangers, and may put the plane into unusual attitudes, such as near-acrobatic maneuvers, pulling high-G's, both negative and positive, or a combination of control inputs in order to dislocate and thwart any threat.

Currently children under 2 can travel as "lap children," which places them at risk of becoming human missiles during any sudden changes in the plane's position. It is unconscionable that infant seats should be ignored. while every item on the plane, including coffeepots and pets, must be secured, and are safer than our infants.

Child restraint seats have been required since 1982 for children traveling in cars at 50-60 mph, a fraction of the 500-mph flight speed.

As a follow-up to our September 28th FAA meeting, and in light of these increased risks, we are asking the Department of Transportation (DOT), the FAA, and the President, to approve a long overdue, much needed, common sense mandate that ALL passengers, including infants, be protected with a safe seat restraint.

If you would like to help with this action let us know! Contact your U.S. Senator and representative in Congress and tell them to support the Emergency Order Requiring Child Restraint Seats for ALL Children.
